WEST TRENTON, NJ – Homasote Company, America's oldest manufacturer of building products made from recycled cellulose fiber, recently released the Company's unaudited summary of financial operating information for the first nine months of 2019 and comparable figures for the same period in 2018.

Net sales for the three months ended September 30, 2019 were \$4,900,079, compared to \$5,020,786 for 2018, a decrease of \$120,707. Net loss for the three months ended September 30, 2019 was (\$269,802), or (\$0.75) per share, compared to net income of \$310,985, or \$0.86 per share, for the year earlier period.

Net sales for the nine months ended September 30, 2019 were \$15,359,186, compared to \$15,662,848 for 2018, a decrease of \$303,662. Net income for the nine months ended September 30, 2019 was \$212,607, or \$0.59 per share, versus net income of \$1,388,415, or \$3.86 per share, in 2018.
